The Edinburgh Curling Club Bye-Law (8)

Elections of President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors

These Bye-Laws are written under and with reference to the Edinburgh Curling Club's Articles of Association, is subject to all definitions and terms therein and have been adopted by the Edinburgh Curling Club on 1985 and amended on 16/1/11.

Elections of President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors

(8.1) Where in terms of Articles 17/5/2007 There is a requirement to elect a President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors the arrangements for such elections shall be set out in this Bye-Law.

(8.2) Nominations for the posts of President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors shall be lodged with the Edinburgh Curling Club by 1st March in each year.

(8.3) Each nominee must be a member of the Edinburgh Curling Club

(8.4) There must be lodged by or on behalf of each nominee:

- (a) A completed nomination form signed by the President or Secretary of any Local Club making said nomination and including a statement to confirm the nominee's willingness to act in the relevant post if successful; and
- (b) A short curriculum vitae in the form required within the nomination form asserting the nominee's relevant experience, skills and fitness for the post nominated.

(8.5) For avoidance of doubt, nominations for President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors will fall to be considered at the next AGM and voted upon by a simple majority vote, by a count of hands or ballot of the members present in person.

(8.6) The result of all elections, will be posted on the Edinburgh Curling Club notice board.

(8.7) The new President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors will assume office from the end of the AGM after their successful election. A retiring President, Vice President, Honorary Treasurer, Honorary Secretary, Operations Director & Ordinary Directors who are retiring will be deemed to have retired as at the end of the AGM.

(8.8) Voting may be dealt with electronically by any member if and when the Edinburgh Club offers such a facility.
